

True Planetary Motions and Rhythmic Climatic Changes

Observation of the moving sun is the key to long-term forecasting. Brilliant minds like that of Milankovich, Einstein, Carl Sagan, et al made the same mistake. Not one of them made their projections relative to a moving sun. It never occurred to them that they should make their projections on planetary motions from the point at the center of the orbit formed by the sun.

1. Introduction

As mankind searches for the missing puzzle pieces to predictions of long term climatic cycles, polar shift, extinction of the species, cyclical population explosions, answers to alternatives to the theory of plate tectonics, reversals of geographic climatic manifestations, many and most of the unanswered questions will be now evident in this discovery of true planetary motions and rhythmic climatic changes.

Observation of the moving sun is the key to true planetary motions and long-term climatic forecasting. True planetary motions and rhythmic climatic changes have not been accurately charted as this key factor has eluded all previous astronomical thought. No one has made their projections relative to a moving sun. It has never occurred to man before to make projections based on an orbiting sun moving anti-clockwise on the inner hub of our galaxy. This observation changes everything in accurate charting of true planetary motions and cyclical climatic manifestations specifically the charting of ice-ages, hot-spells, extinctions and renewals of species over 25,000 year cycles.

All projections on true planetary motions as they affect long term climatic changes should be made from the point at the center of the orbit formed by our star, the sun, on its spiral cyclical path on the inner hub of our Milky Way galaxy. Mankind has failed to discover true planetary motions up to this discovery because he failed to observe that all planetary orbits, when extended in a concentric way, touch the point at the center of the orbital plane of the sun as it spirals in 25,000 years rhythmic cycles affecting every planet's climatic patterns caught in its magnetic field. This observation has eluded man throughout history from time immemorial thusly the concept of true planetary motions has not been discovered by man up to this time, until now.

The theory of shifting continents and tectonics is now reduction ad absurdum. In 1982, Peter Warlow proposed that an extra-terrestrial source is the trigger mechanism for pole shift [1]. He had no idea as to how and why the pole shift occurs. He, like the others, thought that the earth tumbles at some point in time. The accurate projections of the sun's rotation in its 6,000, 12,000 and 25,000 year complete cyclical patterns will demonstrate pole shift occurring slowly and gradually over thousands of years. The timing of these reversals is now predictable based on this astronomical time clock projection placing the sun on an anti-clockwise spiral path on its orbital ellipse on the inner hub of our galaxy. Pole shifts occur once every 12,500 years precisely, north becomes south due to the earth and other planets being entrapped by the sun in its own cyclical dance around the inner

hub of our Milky Way galaxy. It is precise and systematic, no sudden somersaulting of the earth, as still envisioned by some scientists, in an attempt to explain magnetic pole shift. They just couldn't figure how it occurred although the evidence of reversal is there. Tectonics and continental drift is also misdiagnosed as a remedy to explain the evidence of once tropical terrain, such as coral reefs in Arctic regions. They moved the continents on plates in their puzzlement, ignoring the most logical pattern of solar cycles affecting climatic reversals. It never occurred to mankind before that the sun indeed has a dynamic persona and is constantly spiraling in its own anti-clockwise orbit around the inner hub of our galaxy taking us and our other 8 neighboring planets along with it causing ever escalating manifestation of climate change on the planets. This is the key to true planetary motions. It is a discovery that cannot be ignored, we have no other choice by logical precise charting of this planetary model to view the true motions of our star the sun in its true cycles of 25,000 year rhythms, with every notch on the astronomical time clock representing 2,083.333 years, producing two ice-ages, and two hot spells, as well as two magnetic polar shifts or reversals in every 25,000 years in 12,000 and 6,000 year increments. So now we are witness to the fact that continents do not drift, the sun cycles around the galaxy affecting climatic manifestations on every planet in the solar system is the key to climatic changes on a long and short term basis throughout the galaxy. Pertaining to Kepler's Laws on the motions of planets in relation to the distance from the sun, velocity, perihelion, aphelion, radius vector etc., these were his laws relating to planets behavior, none of which is relevant, applicable to the vastly prominent behavior of our sun star evident now in this astronomical model of the laws of true planetary motions based on the effect of our rotational sun star in our galactic domain.

2. The Mistake of Explaining Climate Change with Continental Drift and Tectonics

Some scientists, who are advocates of tectonics, claim that a spreading sea floor resulting from moving continental plates is the main factor in magnetic reversals of the poles throughout the ages. This is wrong. The sun moves in circles affecting climatic changes on all the planets. The continents cannot and do not move. We are focusing on tectonics or shifting continental plates, to attempt to understand and explain the evidence of coral reefs or tropical remnants in non-traditional tropical places, instead of observing the sun that does a spiral orbit on the inner hub of our galaxy, with the nine known planets crossing it at right angles at all times. This key equation as the core of true planetary motions

must be taken into consideration in gauging cyclical climatic manifestations over long term periods. We do not have to move the continents on plates as thin as toilet paper relative to the thickness of the earth's crust, to account for the tropical coral reefs that are today located in places like Spitsbergen in the Arctic and other Antarctic regions of the globe. This theory of tectonics and plate shifts, including whole continents "shifting" has emerged in recent decades as acceptable in an attempt of man to explain the above phenomena.

The rising oceans, the hot-spells and dark-spells, are the direct causes of the extinction of the larger species that roamed the earth for three billion years. Some scientists believe the earth was hit by a meteorite that raised so much dust, that the whole earth was in complete darkness for a long period. There was darkness, but for other reasons. The hot and dark spells return whenever the sun gets to point 3 or point 9 on its cyclical orbit. This is a time of complete devastation on earth. Nothing survives the periods of unmerciful heat and sun for 6 months and darkness alternately for 6 months for thousands of years. Meteorites had nothing to do with the extinction of the pre-historic animal species, as was the accepted theory up till today. Now there are certain posts around the seeping of theory based on climatic change being the cause of the extinction of the pre-historic species which is coming now some thirty years after this discovery of climatic change based on solar influences describe and documented in this manuscript. Adhemar was right when he said that the earth was in the grips of an ice-age 11,000 years ago and that the one before was 22,000 years ago and 33,000 years ago throughout time. He knew of this cyclical rhythm, yet he failed to devise the correct projections. Of all the modern astronomers from Kepler to Carl Sagan et al, James Croll and Joseph Adhemar came the closest to discovering true planetary motions and long term forecasting of ice-ages and interglacial etc. If only these eminent scientists had deduced a way or had they given birth to the idea making all projections from a point at the center of the sun's ellipse while the sun made its round on the inner hub of our galaxy, the long term forecasting of ice-ages, magnetic pole reversal and catastrophic climatic changes would have been possible earlier in this century.

3. True Gauging of Long Term Climate Change Still not Possible via Current Methods

Man is still attempting to gauge and predict ice-ages by examining ice-samples and tree barks, holes in the ozone, sun flares, and most currently carbon in the atmosphere for evidence of cyclical climate change when the accurate forecasting will now be available through this documented discovery of solar orbital patterns producing cyclical ice-ages, and alternating contrasting cyclical hot-spells in 6,000, 12,000 and 25,000 year cycles repeatedly throughout geological time. Global warming is nothing new in geological time. Man has not been able to gauge planetary motions for more than 6,000 years since he emerged from the last hot spell of devastation which depleted the human race and caused us to start afresh again with emerging out of the hot dark spells. Accurate long term climatic forecasting is finally here based on accurate projections of this astronomical time clock through geological time. The key is in the concept of a moving, orbiting rotational sun, the grand master blaster of all planetary motions and climatic manifestations in our galactic neighborhood. Man has sheer ego in assuming the position of causing global warming on a miniscule temporary basis, as mankind's

global "carbon footprint" is mere dust in the wind compared to the still incomprehensible and massive influence of the effect of our star sun on our and every planet co-existing in our galaxy.

4. Gradual and Predictable Magnetic Pole Shift

There is perfect order in the universe. Pole shift occurs only because of re-distribution of sunlight due to our shifting sun. We should no longer have problems forecasting cyclical climatic changes, ice-ages, rising oceans, population explosions, hot-spells and cyclical reversals of the magnetic poles by careful charting of the anti-clockwise orbital dance of our star sun on the inner hub of the Milky Way galaxy. The only way to chart the cyclical climatic changes of our planet earth and other planets in the solar system is to approach this effect on the impact of a moving, rotating and orbiting sun. Dr. Flodmark in his paper [2] predicts that the earth is nearing the moment when another pole shift will occur within the space of a single day. This is not only impossible but will be proven to be highly illogical based on the predictions of long term climatic changes, pole shift, population explosions, climaxing destruction and renewal based on the cycles of our rotating, orbiting replenishing star sun. Cyclical and rhythmic occurrences of ice-ages, alternating hot-spells, both accompanied by ravaging population explosions, cyclical destruction and renewal as also charted by the Mayan projections, will prove to be precisely demonstrated by this astronomical time clock projection of long term climatic reversals over vast spans of geological time past and future.

Never before has there been accurate charting in a climate model based on such long term time spans. Based on accurate charting of solar orbital cycles of this discovery, the progression of magnetic pole shift as a gradual and long term cyclical occurrence will be demonstrated in complete precision in this true planetary motions model. Until now, man has always thought in terms of a somersault or tumbling motion that occurs suddenly. They have seen the evidence of these reversals, but still no one could figure out how they occur, or why, until now. Although we have the evidence of pole shift, scientists today still speculate that these reversals take place suddenly as earth does a "somersault". Upon analysis of this discovery's projections of cyclical planetary motions based on an orbiting sun it will become clearly evident that the somersault point of view is not only impossible but highly illogical.

John Gribbon stated, "Nobody knows for sure how or why the earth's magnetic field reverses its polarity from time to time but reverse they do" [3]. Again he came so close to unveiling the concept of magnetic pole shift as it is demonstrated in this documented discovery's projections of true planetary motions and cyclical climatic manifestations based on a moving orbiting sun. The advocates of continental drift conveniently introduced tectonics to account for pole-shift and other catastrophic climatic changes. We must now observe the moving sun in order to observe true planetary motions. **The observer must be placed outside the galaxy.** The green house effect is indeed real, but the effect that pollutants have on long term or short-term climatic changes is so infinitesimal that whatever man does cannot and will not cause the slightest ripple in the winds of change relative to climatic changes on earth compared with the effects created by the behavior our star the sun. **We must turn our attention to the orbiting sun. We are looking the wrong way, at the green house effect and global warming to grossly misinterpret the current temporary climaxing of climate change before the advancing ice-age in 500 to 1,000 years.**

5. Migrating with Climatic Change Essential to Survival

Travel to the neighboring planets must be attempted before the full manifestation of the advancing ice-age, as earth is spiraling into the dormant stage that Mars is in today. All Mars's water is locked up in ice in its current ice-age. We must move toward the inner planets within 1,000 years or be trapped by the onslaught of ice that has already begun to creep into the equatorial belts evident by the now clearly visible pattern of increasingly violent winters globally. Man must migrate with climate change or die like the many civilizations, such as the Mayans, whom even though excellent navigators of the heavens and the most precise astronomers of earth's astronomical time records, also perished leaving their belongings as though a mysterious and unmerciful overnight train crashed into their once astounding civilizations. What was the reason? They too did not move with climate change as the mammoths and dinosaurs attempted to from natural instinct and when the land bridges became impassable by encroaching ice eventually got trapped and perished for lack of food and long periods of sunlight along with long periods (6 months at a time) of darkness during the alternating hot spells. These alternating hot spells see-sawing with the contrasting ice-ages are as such compared to mother earth's female reproductive and degenerative cycles, such as the micro-cosmic cycles of a woman's reproductive cycles. The sun is the impregnator and the destroyer both!

We are witnessing today the cyclical drama unfolding of this rhythmic stage play, as countless nations are panting and heaving from the phenomena of cyclical climate change, both of the temporary global warming nature and the combined effects of the oncoming and advancing ice-age to climax within 500 to 1,000 years lasting for over 2000 years, before normalizing again to periods of unchanging climate as we know it today. These are the patterns of the astronomical time clock that are projected in this discovery in the accurate charting of cyclical climatic conditions over eons of past and future time spans. Between now and the full climaxing of the coming ice-age in several hundred years by the year 2990 to 3000, millions will die daily as population explodes cyclically, climatic reversals of drought and monsoons, tsunamis, and general chaotic upheavals permeate every corner of the planet in the great climax, a very erotic play of cycles, repeating in eons of time since time immemorial to infinity. Nothing is left to chance in our universe, in all things there is order, even in chaos. The patterns are erratically precise. Man must migrate or die with the cyclic climatic changes.

6. Chronology of the Missing Jigsaw Pieces to True Planetary Motions

There is no other way to determine true planetary motions but by moving the sun in an anti-clockwise manner in spiral circles on the inner hub of our galaxy, with all nine known planets orbiting and crossing that orbit of the sun at right angles at all times. This is the essential key to true planetary motions, ultimately governing all dynamics of the perpetual cyclical waltz between earth our star the sun and our planetary neighbors. The reason true planetary motions had not been discovered until now is that the sun being seen at the center of the galaxy is still perceived as being in a state of stationary rotation. Illustrations by Mel Hunter show the sun from a cloudy birth to a frozen extinction in 50 billion years. For four hundred years since Copernicus,

Galileo and Kepler, astronomers still believe that the sun sits in stationary rotation at the center of our galaxy, with the nine known planets moving around it. This discovery of true planetary motions and rhythmic climatic changes based on the orbital path of a moving sun that affects all climate on our planet is here to replace old incomplete concepts.

Kepler's Laws were based on the concept of a stationary sun. Kepler never explained the missing pieces of his three laws. Later in the chronology of astronomy, Newton came up with some answers. He attributed the behavior of the planets to a most fundamental law- the Law of Gravitation. He, too, as Kepler, used the center of the sun for his projection, instead of the point at the center of the sun's orbital plane. Not knowing that the sun moved, nor how it moved, he as Kepler, also placed the sun in a stationary position or on a straight course to its death in billions of years. Later, Adhemar and James Croll in the 1860's started us off on the correct path to an astronomical theory on ice-ages. James Croll was revolutionary in his theory which was a complete shift from Kepler's theory on planetary motions. Croll discovered that the earth's orbit is almost a circle and not the ellipse that Kepler projected.

7. Long Term Climatic Forecasting Finally Here

At this point in geological time we are witnessing the rhythmic palpitations of earth in many places globally such as the Philippines, Australia, Germany and Brazil to name just a handful. Now, we must visualize a cycle of teetering, like a see-saw as the normal weather patterns click a notch ahead into a decided season of unchanging and cataclysmic weather (the coming ice-age) within 1,000 years by 2,900 to 3,000 lasting for 2,000 years. Any space travel that mankind will attempt to triumph over in this life cycle(as in Mayan Calendar cycles) must be done within the next 500 to 1,000 years to fall within the practical and feasible window of time space travel before the onslaught of climatic manifestations of the coming ice-age. NASA and world leaders need to know this!

This is accurate and precise like clockwork, as the last ice-age was indeed 12,000 ago and the one before that, 12,000 before that. Technology of mankind always climaxes in the volatile periods of climaxing into either an ice-age or hot-spell, the last hot-spell being just before our first records of historic data on human kind around 6,000 years ago (3,000 years B.C). During this time the planet was experiencing the devastating cataclysmic effects of the last hot spell. Nothing lives through these periods when there is 6 months darkness and 6 months of light at a time. This is what killed off the last remnants of the surviving species of large mammoths and pre-historic animals that survived the last ice-age 12,000 years ago. All this is because of the moving sun. This observation of a moving sun on the inner hub of our galaxy changes everything man once thought about planetary motions in the past. In this advanced technological age, man is yet to be able to predict/forecast weather for more than four or five days at a time. With this projection and climate forecasting model accurately charted, if one were to name a year, in the ancient past or forward into the future it can tell you what the weather was then or what it will be at that time in the future. All this is based on this discovery of cyclical climatic changes based on an orbiting sun in this discovery of true planetary motions.

8. Demonstrating the Model and Projections of True Planetary Motions & Climatic Changes

In 1994, I went on to draw up these planetary laws: [4]

1. The sun must move anti-clockwise in a spiral circle on the inner hub of the galaxy once every 25,000 years, precisely. There are two ice-ages and two hot-spells per cycle, with magnetic pole shift (reversals) every 12,000 years coinciding with the ice-ages.
2. All nine known planets, plus the two which were newly discovered by the Chinese and named Purple Mountain 1 and 2, must orbit the sun on the same plane at all times forming concentric circles which when extended must intersect with the center of the sun's orbit while crossing the plane of the sun's orbit at right angles at all times.
3. There shall be no wobble or gyration or nutation of earth's axis or of the axes of other planets in the galaxy. **ALL** axes of the planets **MUST** point in fixed directions relative to other stars as the sun makes its rounds.

That orbital path of our sun is so colossally large that it appears (from within our galaxy) that the sun is stationary. To observe the sun's curved circular spiral orbit in space and time one must place oneself as an observer **outside the galaxy**. This is how this astronomical celestial parade became visible as this discovery.

Compared to a woman's reproductive and monthly cycle, we are now in the pre-menstrual cycle, at 6:30 on the astronomical time clock where mother earth is heaving and panting, hot and cold into the fullness of the full blown ice-age. With it comes over population of the maximum of mankind's technological advances from the last period of extinction 6,000 years ago to its fullness of filth, over population, hunger, cataclysmic erratic climatic manifestations (some of which we are experiencing today), to millions of deaths, in the path of her cycle to her full blown period, the ice-age. She will then stay for three days (about three thousand years) in this cycle, based on the sun's orbital path, and then she (earth) will again begin to thaw out, returning to normal and unchanging stable weather (like today) until her next pre-menstrual cycle in another six thousand years by the year 8000 to 8500, by that time there will be a full blown hot-spell when the clock is at 3:00 on the astronomical time clock. If mankind is still here to witness it, this discovery will serve a time capsule to attest to the knowledge that transcends time for all humanity.

9. Unanswered Questions

Many questions are yet unanswered that can and must be addressed by this long term climate change model discovery. Mankind has little or no effect whatsoever on climate change, his "carbon footprint" being infinitesimal in the grand scheme of the churning of the wheels of geological and cosmological time and events. Mankind is on the verge of the most cataclysmic manifestation of climate change in the 6,000 years since the last planetary motion shift in climate change, which was the last hot-spell of 3000 B.C. We are now in the early stages of the next oncoming natural progression in planetary motion cycles caused by our moving/orbiting sun, the already advancing ice-age. This is to climax in approximately 1,000 years by the year 2990 and will last until the cessation of its cyclical time span of 2,000 years ending in the years around 4500 A.D. This discovery's three laws of True Planetary Motions describes these cycles in complete and accurate precision.

Questions relative to true planetary motions, precise timing of ice-ages, prediction of long term climatic changes, cyclical and gradual reversals of the magnetic poles, the extinction of the dinosaurs and other pre-historic species, the occurrence of cyclical hot-spells every 12,000 years between ice-ages, rising oceans, cyclical population explosions etc. are the laundry list to the challenges yet unanswered until now by this discovery of true planetary motions. Population explosion or growth must be harvested immediately. As we approach the advancing next ice-age within 500 to 1,000 years by the year 3000, man is unable to cope with disease, hunger, filth that will grow around him ten-fold. He too, like the pre-historic animal species will die as the ice-belts close to within 10 or 15 degrees from the equator, as did countless ancient civilizations in pre-history dating to the last ice-age 12,000 years ago, and the recent alternating hot-spell just 6,000 years ago. This period dates to 3,000 years before Christ (B.C), populations exploded, cannibalism was evident, climatic horrors of six months darkness and six months light signaled in the global exodus then as has already begun in the 21st century evident by the onslaught of decided climate change in this final hour preceding the advancing ice-age. This distribution of sunlight as the sun's position in its orbital path affected sunlight shifts on earth caused major havoc and decided death by the millions in the last hot-spell 6,000 years ago. This cyclical rhythm of climate change is now predictable and easily gauged by these astronomical projections of micro and macro planetary cycles throughout geological time. The Sahara and other arid areas are moving south as the ice-belts begin to creep down from both Northern and Southern hemispheres leaving everything covered in ice for up to one thousand to three thousand years starting today. To visualize this, imagine the icing on a cupcake being on both sides top and bottom, now as the heat source (the sun) hits areas repeatedly only at points within 10 to 15 degrees of the equator (the middle of the cupcake) leaving the top and bottom hardened in its icy state. The middle latitudes near the middle of the sphere (cupcake) will be adequately warmed to sustain life, while everything in the top and bottom of the cupcake (earth) shall be completely covered in perpetual ice (icing) for as long as it takes for the sun to orbit into her path exiting that cyclical positioning on her 25,000 year cycle.

10. Harnessing the Potential of Mass Extinction of Human and Animal Species

Based on various accounts of Biblical and historic findings such as Noah's Ark, it is already happening in the streets of Calcutta in India as we approach the advancing ice-age in just 500 to 1,000 years. It can also be seen in the streets of California and Somalia, Brazil, and Australia, the occurrences of repeated and more frequently occurring cataclysmic climatic manifestations cannot be ignored by world governments any longer. The climate talks of Copenhagen in December of 2009, were inconclusive and left world governments still scrambling for closure in this ongoing and dramatic unfolding of unprecedented climate change globally. The population explosion is definitely on, as it precedes every ice-age (now advancing) and every alternating hot-spell (every 6,000 years). These alternating micro-cycles as are now termed herein, (less than 25,000 years respectively) are accurately charted on the astronomical time clock of projections of solar and true planetary motions. We are creeping into the coming advancing ice-age with blinders on, this discovery is crucial to mankind's survival within the next 3,000 years. World governments

globally must take heed to this crucial time clock, never before made possible.

11. Climate Change in Proper Political, Economic and Personal Perspective

This discovery of accurate and true planetary motions based on the macro-cyclical solar orbital projections should make us aware of the devastating and uncontrollable catastrophes that overcome earth, one of which is moving in on us today, the advancing ice-age. This will manifest into colder and colder winters both in the Northern and Southern hemispheres, creeping up and down to areas never before seen as wintry terrains (such as already evident in the Southern states of the United States in the last two winters of 2009, 2010 and certainly through the current 2011 global freeze. People are confounded by these unprecedented phenomenal contrasts in climatic changes planet wide. The recent Climate-gate cover ups showing global cooling over the past decades did not prove to be as convincing in the light of global pre-occupation with political action committees, greenhouse warming fanatics and politically and economically motivated campaigns for cutting back of greenhouse gases to try to prevent climate change. The recent phasing out of the position of the White House representative on Energy Policy and Climate Change shows clearly the position of the government on the inability to understand and make policy on this ongoing and crucial topic.

China is now leading the way in harnessing population growth. Today we live in one of the best periods. The sun is now at 6:30 point on its orbit, in 1,000 years the sun will be at point 6, and it is another ice-age in both hemispheres simultaneously. We are well into an ice-age today. We are halfway there.

We are focusing on tectonics or shifting continental plates, instead of observing the sun that does a spiral orbit on the inner hub of our galaxy and that is where we are teetering on stagnancy of scientific discovery. We do not have to move the continents on plates to account for the tropical coral reefs that are today located in places like Spitsbergen in the Arctic and other Antarctic regions of the globe. The key to this phenomenon is in the observation of our moving sun on the inner hub of our galaxy as it affects shifts of sunlight. Similarly the perception of the apparent variation in degrees of axial pole tilt is explained by the shifting of light cast as the sun describes a circle on the inner hub of our galaxy.

During the volatile periods of climaxing into either an ice-age or hot-spell which coincided just before our first records of historic data on human kind around 6,000 years ago (the last hot spell occurred at point 9 on the astronomical time clock projections around 3,000 years B.C). The planet was experiencing the devastating cataclysmic effects of the last hot-spell which killed off the remaining animal species after the last ice-age some 12,000 years ago. We are moving surely into the next ice-age in precise timing of every 12,000 years, by the year 2990 to 3000. It is accurate as clockwork based on this climatic prediction model using the projections of an orbiting sun. This observation of a moving sun on the inner hub of our galaxy changes everything man once thought about our cosmology as we unveil the discovery 'True Planetary Motions and Rhythmic Climatic Changes'.
